

MOON FESTIVAL DRAWING RULES & REGULATIONS

1. Date(s) and Time(s):

2. On each giveaway date, between 6:00 a.m. and 11:15 p.m., all Promotions Participants are eligible to receive one manual drawing entry into that giveaway date's drawings by receiving one of the qualifying hands.

3. The manual drawing entry for the giveaway date will be issued by a dealer. The Promotions Participant must completely fill out both halves of the manual drawing entry with their first and last name that matches his or her Government ID or Commerce Casino Players Card.
4. The Promotion Participant will retain half of the ticket for their records and return the other half to the dealer.
5. Promotions Participants are responsible for their manual drawing entries. Replacement manual drawing entries will not be issued.
6. On the giveaway dates manual drawings will be conducted at 11:00 a.m., 1:00 p.m., 3:00 p.m., 5:00 p.m., 7:00 p.m., 9:00 p.m. & 11:00 p.m. to select winners of \$1,500.
7. On the September 10, 11 & 12, 2022 Grand Prize dates, a manual drawing will be conducted at 11:00 a.m. and 1:00 p.m. to select winners of \$1,500 and 3:00 p.m., 5:00 p.m., 7:00 p.m., 9:00 p.m. & 11:00 p.m. to select winners of \$1,500 and a Grand Prize Envelope.
8. A Casino Representative will contact Surveillance to monitor the drawing.
9. At the designated drawing time, a Casino Representative will draw by hand and remove one manual drawing entry from the drawing drum.
10. Any incomplete or invalid manual drawing entry or foreign objects placed inside of the drum shall not be considered eligible.
11. Once a manual drawing entry has been selected from the drawing drum, it shall not be replaced into the drum.
12. Throughout the casino, the winning manual drawing entry, drawing entry number and name will be displayed on the promotional television screens and announced.
13. The winner(s) will have 3 minutes from time of the conclusion of the initial announcement to report to a Casino Representative at the place of the announcement.
14. Winner(s) must be present to win.
15. Once the winner(s) announce their presence he or she must present his or her matching manual drawing entry and valid photo identification or Commerce Casino Players Card within 3 minutes of checking in with the Casino Representative. If the drawing winner cannot produce, a valid photo identification or Players Card within the 3-minute period they will be determined ineligible as a drawing winner and another winner will be selected.
16. If a winner is found to be related to a Commerce Casino employee or a relative of an employee (as defined in the Commerce Casino official rules) they will be determined ineligible as a drawing winner and another winner will be selected.
17. If a winner is not present, the above process will be repeated up to 2 additional times (for a total of 3 times) or until a winner is found. If a winner cannot be found by conclusion of the 3rd time, there will be no winner for that drawing time. This process will conclude if all of the manual drawing vouchers are exhausted.
18. Promotions Participants may be selected as a drawing winner more than once.

19. On the September 10, 11 & 12, 2022 Grand Prize Drawings, at the conclusion of 11:00 p.m. drawing all previous envelope winners will have until 11:15 p.m. to check in with a Casino Representative at the drawing area.
20. The present Drawing Winners will decide to select from one of five envelopes or chop the \$30,000 grand prize evenly amongst themselves. All players must be in agreement for a chop to take place. If a drawing winner wants to choose from the five envelopes, they may do so. If they select the envelope with Grand Prize messaging, they will receive \$30,000.
