2. On each giveaway date, between 6:00 a.m. and 1:45 a.m., all Promotions Participants are eligible to receive one manual drawing entry into that giveaway date's drawings by receiving one of the qualifying hands.

3. The manual drawing entry for the giveaway date will be issued by a dealer. The Promotions Participant must completely fill out both halves of the manual drawing entry with their first and last name that matches his or her Government ID or Commerce Casino Players Card.
4. The Promotion Participant will retain half of the ticket for their records and return the other half to the dealer.
5. Promotions Participants are responsible for their manual drawing entries. Replacement manual drawing entries will not be issued.
6. A Casino Representative will contact Surveillance to monitor the drawing.
7. At the designated drawing time, a Casino Representative will draw by hand and remove one manual drawing entry from the drawing drum.
8. Any incomplete or invalid manual drawing entry or foreign objects placed inside of the drum shall not be considered eligible.
9. Once a manual drawing entry has been selected from the drawing drum, it shall not be replaced into the drum.
10. Throughout the casino, the winning manual drawing entry, drawing entry number and name will be displayed on the promotional television screens and announced.
11. The winner(s) will have **5 minutes** from time of the conclusion of the initial announcement to report to a Casino Representative at the place of the announcement.
12. Winner(s) must be present to win.

13. Once the winner(s) announce their presence he or she must present his or her matching manual drawing entry and valid photo identification or Commerce Casino Players Card within **3 minutes** of checking in with the Casino Representative. If the drawing winner cannot produce, a valid photo identification or Players Card within the 3-minute period they will be determined ineligible as a drawing winner and another winner will be selected.
14. If a winner is found to be related to a Commerce Casino employee or a relative of an employee (as defined in the Commerce Casino official rules) they will be determined ineligible as a drawing winner and another winner will be selected.
15. If a winner is not present, the above process will be repeated up to 2 additional times (for a total of 3 times) or until a winner is found. If a winner cannot be found by conclusion of the 3rd time, there will be no winner for that drawing time. This process will conclude if all of the manual drawing vouchers are exhausted.
16. Once a winner is verified, they will reach into a drawing drum to select one (1) envelope to reveal their cash prize. Prizes will range from \$888 - \$2,500.
17. **Grand Prize Drawing 1/21, 1/22, 1/23:** Winners of the 6:00 p.m., 8:00 p.m., 10:00 p.m., 12:00 a.m. and 2:00am drawings will also win an invitation to return for the Grand Prize drawing. At the conclusion of the 2:00am drawing, all five winners will return to pick from one of five sealed envelopes containing paper keys. Winners will have until 2:05 a.m. to check-in with a Casino Representative or forfeit their participation in the Grand Prize Drawing.
18. The car is paid out as an \$115,000 credit to a predetermined dealership or a \$100,000 cash option.
19. Before the envelopes are opened, the winners have the option to split the cash value evenly among each winner. If they do not choose to split the cash value, each winner will select an envelope, the envelopes will be opened and the key that states "CAR" is the winner.
20. If the car is selected, the winner will be responsible for paying state taxes, licensing and fees before taking delivery of the car.
21. All drawing tickets will be emptied at the completion of the 2:00am drawing
22. Players may only win multiple Red Envelope Drawings per day and one (1) Grand Prize Drawing per day.
